Foreign Student Application;

Students to be Accepted

- (1) Postgraduate programs provided that the foreign national candidates who will apply are in the graduate status, and the foreign national candidates who will apply to the associate degree and undergraduate programs are in the last year of high school or have graduated;
- a) Foreign nationals,
- b) Those who are Turkish citizens by birth but who have been granted permission to renounce Turkish citizenship from the Ministry of Internal Affairs and whose children who do not get the score registered in the certificate of renunciation of Turkish citizenship document that they have a Document on the Use of Recognized Rights in accordance with the Turkish Citizenship Law (Article 7 of the Turkish Citizenship Law No.5901) 1) A child born in a marriage union from a Turkish citizen mother or father in or out of Turkey is a Turkish citizen.” Candidates who will apply for the quota should examine the Turkish Citizenship Law.),
- c) Citizenship acquired after being a foreign national and T.C. naturalized / dual nationals in this situation,
- d) Those who are T.C. nationals and complete their secondary education in a foreign country excluding the TRNC (including those who complete their secondary education in Turkish schools in a foreign country other than the TRNC)
- d) Those who are TRNC nationals, residing in the TRNC and have completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005-2010 are accepted.

Students who will NOT be Accepted

- a) Those who are Turkish citizens and have completed all of their secondary education in Turkey or the TRNC,
- b) TRNC citizens (except those who have completed their secondary education in TRNC high schools and have GCEAL results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005-2010),
- c) Dual citizens whose first nationality with birth as defined in item (b) of paragraph 5 of this article is T.C. (except those who completed their secondary education in a foreign country other than the TRNC/who completed their entire secondary education in a Turkish school in a foreign country other than the TRNC),
- d) Dual citizens, one of whom is TRNC nationality (excluding those who have completed their entire secondary education in TRNC high schools and have GCE-AL results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005-2010),



e) Those who are Turkish nationals studying at schools within the embassies in Turkey and foreign high schools in Turkey, or those who are dual nationals whose first citizenship is Turkish by birth as defined in subparagraph (b) of paragraph 5 of this article,

f) Applications of those who have been dismissed from a higher education institution in Turkey due to a disciplinary offense are not accepted.
